- 1. How will the LEA, to the greatest extent practicable, support prevention and mitigation policies in line with the most up-to-date guidance from the CDC for the reopening and operation of school facilities in order to continuously and safely open and operate schools for in-person learning?**

This plan will continually be monitored to include updated guidance from the Centers for Disease Control (CDC), PA Department of Health (PADoH), and the Pennsylvania Department of Education (PDE). This guidance will be implemented in consultation with the Bucks County Health Department (BCHD). The plan will be reviewed and revised as necessary at the district level by the CRSD Health and Safety Plan Development Team as well as by building level teams. Any revisions will be recommended to the CRSD Board of School Directors for approval and changes will be communicated to students, staff and the greater school community.

- 2. How will the LEA ensure continuity of services, including but not limited to services to address the students' academic needs, and students' and staff members' social, emotional, mental health, and other needs, which may include student health and food services?**

All school district operations will be implemented in the same manner as those in place prior to the pandemic; exceptions will be delineated within this document.

Educational delivery for the 2021-22 school year:

- Instruction will resume on August 30, 2021 following the traditional schedule for each building.
- The following options will be available to families:
 - Face to face, in classroom instruction.
 - Approved homeschooling coordinated by the student's family with CRSD.

Student medical, social/emotional, and mental health needs will be addressed in the same manner as they have been when students and staff are physically attending school.

Schools will have a building specific process for assessing academic needs that may be interfering with overall progress and a process to identify and address student needs on a case-by-case basis. Similarly, each school community will be provided with a building specific protocol for staff, family, and students to identify and communicate needs related to physical and mental health.

<p>a. <u>Universal and correct wearing of masks;</u></p>	<ul style="list-style-type: none"> • Council Rock has made masks optional via Board approval on May 20, 2021 for all that choose to wear them while on Council Rock School District property or participating in district sponsored events effective May 21, 2021.
<p>b. <u>Modifying facilities to allow for physical distancing (e.g., use of cohorts/podding);</u></p>	<ul style="list-style-type: none"> • Classroom configurations will promote learning and maximize physical distancing where feasible. • Students will be taken outdoors to the extent practicable. • Meetings will occur in person unless designated as virtual by the meeting organizer. If virtual, procedures will be in place for full participation of all involved.
<p>c. <u>Handwashing and respiratory etiquette;</u></p>	<ul style="list-style-type: none"> • General hand hygiene will be practiced throughout the day. • Promote respiratory etiquette of covering mouth/nose when sneezing or coughing. • Proper hand washing and coughing/sneezing technique signs will be posted in all bathrooms and sinks.
<p>d. <u>Cleaning and maintaining healthy facilities, including improving ventilation;</u></p>	<ul style="list-style-type: none"> • All high-touch surfaces and desks cleaned/disinfected by custodial crew daily. • Shared classroom, PE, and recess materials and equipment will be cleaned daily and between uses when practicable. • Water fountains will remain disconnected and staff and students will be encouraged to bring water bottles from home and use filling stations when available.

	<ul style="list-style-type: none"> • Ventilate all classrooms and common areas when available/possible using windows. Use air circulation patterns that push inside air towards open windows. • Needle point bipolar ionization units will be installed in all ventilation systems over the course of the 2021-22 school year.
<p>e. <u>Contact tracing</u> in combination with <u>isolation</u> and <u>quarantine</u>, in collaboration with the State and local health departments;</p>	<ul style="list-style-type: none"> • Use strategies similar to those used with influenza and other infectious diseases in the event of a confirmed case of COVID-19. • Students and employees are highly encouraged to report positive cases of COVID-19 to their building nurse. With regard to COVID-19: <ul style="list-style-type: none"> ○ The BCHD does not require CRSD to notify the BCHD of known or suspected positive cases. ○ THE BCHD will not require CRSD to conduct case investigation or contact tracing or provide notification to individuals to isolate or quarantine. ○ The BCHD will not require any notifications to the school community regarding positive or suspected cases. • The CRSD will consult with the Bucks County Health Department on decisions impacting the closure of classrooms, schools, or the district. • Although neither the influenza vaccine nor the COVID-19 vaccine are required for school attendance or employment, it is highly encouraged for all students and staff to get the flu vaccine and COVID-19 vaccine in consultation with their personal medical care provider.
<p>f. <u>Diagnostic</u> and screening testing;</p>	<ul style="list-style-type: none"> • Educate all stakeholders (students, staff, parents/guardians) on the signs and symptoms of COVID-19. Staff

	<p>and families should self-screen at home prior to attending school or school activities. As per the BCHD, reporting of screening is not required nor does it need to be documented.</p> <ul style="list-style-type: none"> • Individuals who are sick should remain home following relevant Board policies currently in place. • The nurse or designated employee will evaluate any individual who presents with symptoms of illness. Students and staff will be sent home based on established nursing protocols. • Emergency contacts must be up to date. A symptomatic student must be picked up as soon as possible and will not be sent home on the bus. • Until further notice, recognitions or awards for perfect attendance will not occur in order to discourage symptomatic students from attending school.
<p>g. Efforts to provide <u>vaccinations to school communities</u>;</p>	<ul style="list-style-type: none"> • Continue to work with BCHD to provide information on opportunities for students and community members to receive vaccinations. • District communication mechanisms will be used to distribute information regarding vaccination clinics and designated hours when appropriate.
<p>h. Appropriate accommodations for students with disabilities with respect to health and safety policies; and</p>	<ul style="list-style-type: none"> • Special Services staff and building principals will work with families to develop a student-specific safety and education plan for students with unique health needs.
<p>i. Coordination with state and local health officials.</p>	<ul style="list-style-type: none"> • Regular communication will continue with the Bucks County Health Department to discuss possible implementation of any additional guidance from the PDE, CDC and other health related agencies.


